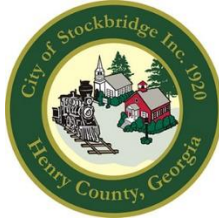

The meeting was called to order by Chair Barney-Duck at 6:32 p.m.

Roll call by Chair Barney-Duck with Committee members Barney-Duck, Charmaine, Jenkins, and Scott present; Johnson was absent.

Motion to approve the Agenda removing the Invocation and Pledge was made by Committee Member Charmaine seconded by Committee Member Jenkins. The motion passed unanimously 4-0.

Motion to approve February 19, 2025 Meeting Minutes was made by Committee Member Scott; seconded by Committee Member Charmaine. The motion passed unanimously 4-0.

New Business

Election of Committee Chair

Committee Member Charmaine nominated Committee Member Barney-Duck for the Chair position. There were no other nominations. The nomination was accepted.

Motion to appoint Committee Member Alicia Barney-Duck as Chair was made by Committee Member Charmaine; seconded by Committee Member Jenkins. The motion passed unanimously 4-0.

Election of Committee Vice-Chair

Committee Member Scott nominated Committee Member Charmain for the Vice-Chair position. The nomination was declined.

Committee Member Charmaine nominated Committee Member Jenkins for the Vice-Chair position. There were no other nominations. The nomination was accepted.

Motion to appoint Committee Member Angela Jenkins as Vice-Chair was made by Committee Member Charmaine; seconded by Committee Member Scott. The motion passed unanimously 3-0-1 (Jenkins Abstained).

Election of Committee Secretary

Committee Member Charmaine nominated Committee Member Scott for the Secretary position. There were no other nominations. The nomination was accepted

Motion to appoint Committee Member Mary Scott as Secretary was made by Committee Member Charmaine; seconded by Committee Member Jenkins. The motion passed unanimously 4-0.

Discussion

The Committee discussed meeting quarterly, and to seek training opportunities, compare the city's ethical guidelines and policy to other municipalities, and to bring recommendations to the City Council for approval. The Committee referenced prior cases where good recommendations have been drafted and submitted to the Mayor & City Council, noting that the Board can only act within the law and the guidelines established, and the GMA Ethics Ordinance adopted by the City.

The Committee set the next meeting dates for July 23, 2025 and October 22, 2025 both at 6:30 p.m.

Motion to adjourn the meeting at 7:17 p.m. was made by Committee Member Jenkins; seconded by Committee Member Scott. The motion passed unanimously 4-0.
